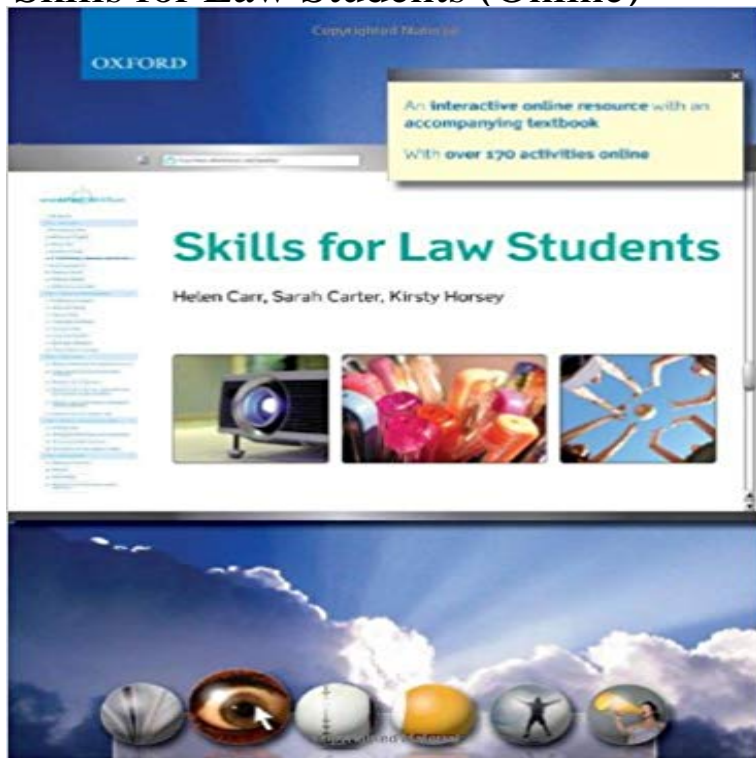


Skills for Law Students (Online)
