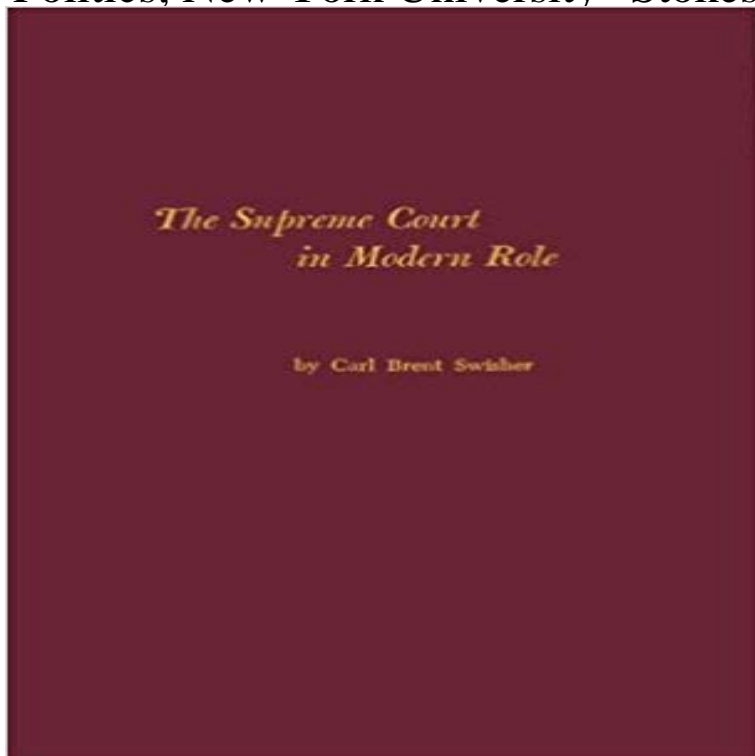


# The Supreme Court in Modern Role: (James Stokes Lectureship on Politics; New York University--Stokes Foundation)
